Panasonic Announces Dividends Forecasts

Osaka, Japan, August 31, 2017 -- Panasonic Corporation ([TSE:6752] "Panasonic") today announced that its Board of Directors has resolved the forecast of interim dividends for the fiscal year ending March 31, 2018 (fiscal 2018). The record date for the interim dividend is September 30, 2017. The forecasts are as follows.

Reason:

Panasonic plans to distribute an interim dividend of 10 yen per share for fiscal 2018 due to its overall policy of distributing profits to shareholders based on its business performance, as well as its current financial position. The year-end dividend has not been decided.
