**Panasonic Announces Dividends Forecasts**

Osaka, Japan, February 5, 2018 -- Panasonic Corporation ([TSE:6752] "Panasonic") today announced that its Board of Directors has resolved the forecast of year-end dividends for the fiscal year ending March 31, 2018 (fiscal 2018). The record date for the year-end dividend is March 31, 2018. The forecasts are as follows.

Panasonic, in dividend policy, distributes profits to shareholders, taking into consideration its business performance, as well as its current financial position.

In view of this basic policy and its upward revision of financial forecasts for fiscal 2018 announced today, Panasonic decided the forecast of year-end dividends for fiscal 2018 of 20 yen per share, increased by 5 yen from the year-end dividends for fiscal 2017.
