

## Panasonic Holdings Sets Terms and Conditions for its Domestic Unsecured Straight Bond Issues

**Osaka, Japan, February 21, 2025** – Panasonic Holdings Corporation (the “Company”) announced that the Company today determined terms and conditions for the issues of unsecured straight bonds in Japan in the aggregate principal amount of 55 billion yen.

The Company decided to issue the bonds in two series, with maturities of three (3) and five (5) years, respectively.

The terms and conditions for each series - namely the Company’s Twenty- ninth, and Thirtieth Series of Unsecured Straight Bonds - are set as follows:

Coupon rate (per annum)	1.240%	1.455%
Issue price	100% of the principal amount	
Interest payment dates	February 28 and August 28 of each year (First interest payment date will be August 28, 2025)	
Maturity date	February 28, 2028	February 28, 2030
Payment date	February 28, 2025

- The Company intends to use the proceeds from the bond issues for the Redemption of Bonds and Working Capital.
- The Company set up a shelf registration for the issue of bonds with a maximum possible amount of 500 billion yen on November 13, 2024.
