- 1. Organizational Changes (Effective January 1, 2026)
 - (1) Objectives and Contents:

Since April 2022, our group has transitioned to an operating company system and has been consistently implementing autonomous and accountable management. We have reorganized into business units of appropriate scale for the industries we serve, and by promoting business specialization to enhance decision-making speed and expertise, we have been working to strengthen competitiveness and improve the corporate value of the group.


At this time, to transform into a company that continues to contribute to society more than ever before and to shift toward a business model and management structure that can sustainably increase corporate value, we will fundamentally restructure our organizational and revenue structures.

Panasonic Holdings Corporation ("PHD"), and Panasonic Operational Excellence Co., Ltd., ("PEX") the group headquarters will review their respective roles and functions to build and realize a lean headquarters and support services.

Specifically, from the perspective of optimizing the entire group, governance functions will be consolidated under PHD, while shared services common to the group will be centralized under PEX.
