## **Panasonic Connect Announces Changes in Officers and Executives of Panasonic Connect Group and Panasonic Connect Co., Ltd.**

**Tokyo, Japan** – [Panasonic Connect Co., Ltd.](#) today announced the leadership structure of the Panasonic Connect Group, effective April 1, 2026. The company also announced appointments of the members of the Board of Directors and the Audit & Supervisory Board Members of Panasonic Connect Co., Ltd., effective April 1, 2026 and June 22, 2026. The appointments effective April 1, 2026 are subject to approval at the Extraordinary General Meeting of Shareholders scheduled to be held in March. The appointments effective June 22, 2026 are subject to approval at the Annual General Meeting of Shareholders, followed by the subsequent meeting of the Board of Directors to be held on June 22, 2026.

### **Panasonic Connect Group Leadership Structure**

As of April 1, Panasonic Connect will transition to a new business operations structure under the name of the Panasonic Connect Group to further strengthen its management system for quicker, more accurate global decision-making. Ken Sain will serve as the Panasonic Connect Group CEO and lead the Group's management and strategic planning.

Furthermore, a governance framework will be established in which independent auditors oversee the decision-making processes and activities of the Panasonic Connect Group, thereby strengthening governance and improving transparency across the Group.
