
### Organizational Changes in the Corporate Technology Sector (Effective October 1)

#### Objectives and Contents:

Looking towards 2040, Panasonic HD’s Corporate Technology Sector has established its Technology Future Vision, which outlines its vision for the future and the direction of research and development. The future the group envisions is a “co-caring” society where individual choice naturally leads to caring for each other and the planet. As Panasonic HD moves forward with the construction of a new medium-term strategy for the Corporate Technology Sector from FY 2025 onward, the company will reorganize the Corporate Technology Sector in order to align with the new Technology Future Vision.
